# "Social Impact Measurement: Reconciling multiple visual perspectives."

## **Background**

Sustainable entrepreneurs seek to tackle social and environmental issues and create positive change in people's lives. This change is usually referred to as "social value" or more simply "impact" (Rawhouser et al., 2019). Despite being a central aspect of sustainable venture performance, previous research shows that sustainable entrepreneurs tend to eschew precise impact measurement and rather use partial at-hand information (Molecke & Pinkse, 2017), imperfect metrics (Andrè et al. 2018), or heuristics (Argiolas et al., 2023) to make specific things more visible than others, guide sensemaking and develop strategies to maximize positive impact. Previous studies have looked at the processes used by entrepreneurs and ventures to simplify reality and develop impact accounts, yet the perspective of how other stakeholders, perceive and evaluate impact(s), and how this may diverge has been overlooked. This is surprising given the relevant role stakeholders play in shaping entrepreneurs'/venturelevel aspirations for impact (Nason et al., 2018). This study seeks to discover how different perspectives of what impact is, co-exist within an impact-driven project, and how this multiplicity of perspectives may even influence the impact results. We empirically explore this in the context of mini-grid projects in rural areas, collecting mainly visual data and interviews from multiple actors. While impact is often described in visual terms, we currently do not understand how *impact* is understood by those who strive to create it (entrepreneurs, donors, investors...), those who operate to create it (technicians, employees...), and those who experience it (beneficiaries, customers...).
